### Rules and regulations of Business talks Sustainability Summit as part of Gdynia Design Days 2022

#### §1

##### General information

1. The Rules and regulations define the rules for participation in the events organized as part of the Gdynia Design Days 2022 festival, organized by the Pomeranian Science and Technology Park Gdynia - Design Centre, a budget unit of the Gdynia City Commune, with headquarters in Gdynia at Al. Zwycięstwa 96/98 PPNT Gdynia - Design Centre, hereinafter referred to as the Organizer.
2. The aim of the events organized by the Organizer is to develop the skills of designing, transforming and implementing projects in the field of contemporary forms of design.

#### §2

##### Rules for participation in events

1. Events organized as part of Design talks Business Sustainability 2022 are payable.
2. The events are addressed to all people interested in the subject matter, in particular to business representatives, entrepreneurs and change agents.
3. Information about the events organized as part of the festival is available on the website [www.gdyniadesigndays.eu](http://www.gdyniadesigndays.eu).
4. In order to buy a package for the event, it is necessary to create a User Account ("My GDD"), in accordance with the regulations available at [www.gdyniadesigndays.eu](http://www.gdyniadesigndays.eu).
5. As part of the free service of maintaining a User Account ("**My GDD**"), the User may:
  - a. access to the Profile, which he can manage himself (including access to payment history / preview of the basket / preview of orders) and to other services available on **gdyniadesigndays.eu** unless the Regulations of a given service provide otherwise (services provided on **www.gdyniadesigndays.eu** to which the User gains access after creating a User Account, are described in the Regulations of a given event; in case of a conflict between these Regulations and other Regulations of a given service, the provisions contained in the Regulations of a given service shall prevail in relation to issues related to a given service; These regulations are available on the websites operating in connection with a given service);
  - b. purchase of tickets for paid events;
  - c. access to registration for free events;
  - d. creating a personalized calendar of GDD events (adding events to favourites);
6. The person who purchased the Premium or Premium plus packages is obliged to select the workshops in which they wish to participate. One workshop should be selected in the Premium package, and the Premium plus package offers two workshops after purchasing. More information about packages can be found in **§3 Fees**.
7. A person under the age of 18 may take part in the events only with the consent of their legal guardians.
8. The organizer reserves the right to change the dates of events without giving a reason. Information about the change of the date will be sent by e-mail to the address provided by the Participant during registration.
9. The participant is obliged to:

- behave in a way that does not endanger the safety of other Participants, in particular complying with health and safety regulations and fire regulations and the provisions of these Regulations,
  - follow the instructions of the Organizer and security services.
10. The Organizer reserves the right to remove Participants from the events behaving in a way that:
    - threatens the safety of other Participants,
    - disturbs order and violates generally accepted norms of behaviour in public places,
    - violates the rules of personal culture and disturbs other Participants in receiving events.
  11. The Organizer reserves the right to refuse to participate in the event to persons under the influence of intoxicants or alcohol.
  12. The Participant transfers to the Organizer the proprietary copyrights, including the right to consent to the exercise of derivative copyrights referred to in The Participant transfers to the Organizer the proprietary copyrights, including the right to consent to the exercise of derivative copyrights referred to in art. 2 and art. 46 of the Act on Copyright and Related Rights in all fields of exploitation referred to in Art. 50 of the Act on Copyright and Related Rights of 1994 to the effects of works created during the Events.
  13. The Participant agrees that the copyrights to any alterations and adaptations (including the right to use and dispose of them) will be the exclusive property of the Organizer in all fields of use referred to in Art. 50 of the Act on Copyright and Related Rights.
  14. The Organizer has the right to keep the works, materials in draft versions, 3D files, photo and text files created during the Events, regardless of the form of their recording, the ownership of which is transferred to the Organizer free of charge at the end of the events.
  15. In the event that third parties make claims against the Organizer for infringement of copyrights or personal rights of third parties related to the work resulting from work during the events, the Participant shall cover the costs and pay compensation related to the claims of such persons.
  16. Without prejudice to the rights of the organizer, the participant may publicly refer to and present works created during the events in an unlimited time and territory.

### **§3**

#### **Fees**

1. Participation in some of the events of the Design talks Business Sustainability series organized as part of the festival is payable.
2. Design talks Business Sustainability Summit will be held on July 8-9 in the Pomeranian Science and Technology Park.
3. The amount of the fee for participation in Design talks Business Sustainability Summit - the main event varies depending on the selected package.
4. There are 4 types of packages available for the Design talks Business Sustainability event:
  - a) early birds - 2 days of lectures + 2 workshops. Price: PLN 90 (including VAT), available on: June 1-14);
  - b) regular - 2 days of lectures + the film "Inventing the world anew" from the Docs Against Gravity program. Price: PLN 90 (including VAT);
  - c) premium: 2 days of lectures + 1 workshop of your choice. Price: PLN 120 (including VAT);
  - d) premium+: 2 days of lectures + 2 workshops to choose from. Price: PLN 160 (including VAT).
5. The fee must be paid at the time of registration, through online payments using the User's

account functionality ("My GDD"), in accordance with the regulations available at [www.gdyniadesigndays.eu](http://www.gdyniadesigndays.eu).

6. The Organizer reserves the right to remove from the list of participants in the event of failure to pay the fee by the indicated date.
7. It is not possible to pay for participation in the event on the spot.

#### **§4**

##### **Resignation**

1. It is not possible to resign from participation in the event after registration and payment.
2. The Participant has the right to give his ticket to a third party, after informing the Organizer of such intention at the following e-mail address: [m.stalewska@ppnt.pl](mailto:m.stalewska@ppnt.pl), no later than one week before the planned event.
3. If the event date is changed, the participant is entitled to a refund.

#### **§5**

##### **Liability and compensation**

1. The Organizer does not insure the participants of the events and is not responsible for any damage: loss, defect, damage of the equipment, clothing and other items belonging to the Participant.
2. The Participant of the event is liable if the Organizer suffers losses as a result of the Participant negligence.
3. In the case of losses, the Organizer will create appropriate documentation including the cost estimate for repairs, and then make repairs in accordance with the cost estimate, a copy of which will be sent to the Participant's address. The Participant will cover the costs of removing the damage in full within 14 days from the date of delivery of the debit note.
4. Persons who have been included on the list of event participants are entitled to reimbursement of the cost of participation in the event for the cancellation of the event.
5. In order to receive a refund of the participation fee due to the cancellation of the event, the Participant will request the Organizer in writing. In this request, the Participant will also indicate the bank account number to which the Organizer will reimburse the cost of participation.
6. The Organizer will return to the participant the above-mentioned amount within 30 working days from the date on which the event was to take place.
7. The reimbursement of the fee covers all the Participant's claims.

#### **§6**

##### **Final Provisions**

1. The Organizer is not responsible for the consequences of force majeure. Force majeure are in particular: weather conditions, breakdowns or disruptions in the operation of devices supplying electricity.
